

SiriusXM Smart Home Display Sweepstakes  
for Automotive Shops

## OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A purchase will not increase your chances of winning. Void where prohibited. U.S. law governs. Open only to Shops in the Territory (defined below)**

**SPONSOR:** The Sponsor of this Sweepstakes is Sirius XM Radio Inc., 1290 Avenue of the Americas, 11th Floor, New York, New York 10104.

**ENTRY PERIOD.** The SiriusXM Smart Home Display Sweepstakes for Automotive Shops (the “**Sweepstakes**”) begins at 12:01 a.m. Eastern Time (“**ET**”) on September 14, 2020 and ends at 5:59 p.m. ET on October 30, 2020 (the “**Entry Period**”). Any entries received after the Entry Period will not be considered.

**HOW TO ENTER.** An owner or authorized employee of a service and repair shop in the Territory (defined below) (a “**Shop**”) may enter the Sweepstakes on behalf of the Shop by enrolling the Shop in the SiriusXM® Service Lane Program (the “**Program**”) and being “successfully activated” in the Program(s). To enter for your chance to win, go to [www.siriusxmforshops.com/NESTHUBMAX](http://www.siriusxmforshops.com/NESTHUBMAX). Follow the instructions listed to enroll in the Program. A properly completed and received enrollment in a Program that is “successfully activated” shall be considered an “**Entry.**”

“**Successfully activated**” means a Shop enrolled and was accepted into the Program, *and* the Shop received an activation acknowledgement from Sponsor no later than the end of the Entry Period. Only one (1) entry per Shop; the first enrollment to be submitted and cause the Shop to be Successfully Activated in the Program will be deemed the only valid entry.

Shops that are currently active and participating in the Program will automatically be entered into the Sweepstakes with one Entry. If a Shop is chosen as the potential winner, it can choose to decline the prize.

**Who Is the Entrant?** The “**Entrant**” is deemed the Shop. A winner can only be a Shop. Sponsor will notify the Owner, Principal, or General Manager of the chosen Shop of its status as potential winner. If the individual who enrolled the Shop was not authorized to do so, or if the Owner, Principal or General Manager chooses to decline the Prize, the Prize will be forfeited, and Sponsor will choose a new potential winner from the remaining eligible Entries. The Shop may, in its discretion, determine who within the Shop may receive one or all elements of the Prize, but regardless of such designation, will be responsible for paying any taxes on the full Prize.

**CONDITIONS OF ENTRY / ELIGIBILITY TO WIN.** This Sweepstakes is open to legally operated shops in the forty-eight (48) contiguous United States and the District of Columbia (the “**Territory**”). By participating in the Sweepstakes, Entrants (i) agree to be bound by these Official Rules, including all eligibility requirements, and (ii) agree to be bound by the decisions of Sponsor, which are final and

binding in all matters Entries that are incomplete or corrupted are void and will not be eligible. Entries that are not “successfully activated” (defined above) will not be eligible. Sponsor and its agents reserve the right to verify eligibility qualifications of any chosen winner. Failure to comply with these Official Rules may result in disqualification from the Sweepstakes. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited by law.

**Who is not eligible to win?** Employees of Sponsor, or its subsidiaries, affiliates, advertising and promotion agencies, retailers or distributors, and members of their immediate family (e.g., spouses, parents, domestic partners, children, siblings), are not eligible to win.

Each prize shall consist of one (1) Google Nest Home Max. Each prize has an Approximate Retail Value (“ARV”) of \$229.00 and 1 YEAR SiriusXM Essential Streaming subscription has an Approximate Retail Value (“ARV”) of \$96.00; the aggregate ARV of all prizes to be awarded is \$3,250.

If potential winning Shop is unable to receive the Prize, it will forfeit the prize and another winner will be selected from among eligible Entries received. No prize substitution, cash substitution, or assignment or transfer of prizes is permitted, except by Sponsor who may substitute a prize, in whole or part, of equal or greater value. In no event shall more than the number of stated prizes be awarded. All prizes are intended to be awarded. All federal, state, local and other taxes, costs, and expenses relating to the use, acceptance and possession of the prize are the sole responsibility of the Shop winner. This Sweepstakes is intended to be advertised to a maximum of 50,420 service and repair shops and 6,998 Ford Professional Service Network shops not yet enrolled in the Program, and a maximum 3,880 shops already enrolled in the Program. Odds of winning are a maximum of approximately 1:61,298.
