

**SiriusXM's Cabo All-Inclusive Getaway Sweepstakes,
for Automotive Shops**

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A purchase will not increase your chances of winning. Void where prohibited. U.S. law governs. Open only to Shops in the Territory (as defined below)

SPONSOR: The Sponsor of this Sweepstakes is Sirius XM Radio Inc., 1221 Avenue of the Americas, 35th Floor, New York, New York 10020.

ENTRY PERIOD. The SiriusXM Cabo All-Inclusive Getaway Sweepstakes for Automotive Shops (the "Sweepstakes") begins at 12:01 a.m. Eastern Time ("ET") on October 18, 2022 and ends at 5:59 p.m. ET on January 06, 2023 (the "Entry Period"). Any entries received after the Entry Period will not be considered.

HOW TO ENTER. An owner or authorized employee of an eligible automobile service and repair shop in the Territory (as defined below) (a "Shop") may enter the Sweepstakes on behalf of the Shop by enrolling the Shop in the SiriusXM® Service Lane Program (the "Program") and being "Successfully activated" (as defined below) in the Program. To enter for your chance to win the Sweepstakes, go to www.siriusxmforshops.com/ShopsCabo2022 follow the instructions listed to enroll in the Program. A properly completed and received enrollment in a Program that is "Successfully activated" (as defined below) shall be considered an "Entry."

"Successfully activated" means (1) a Shop enrolled; (2) the Shop was accepted into the Program; and (3) the Shop received an activation acknowledgement from Sponsor no later than the end of the Entry Period. Only one (1) Entry per Shop. The first enrollment to be submitted and cause the Shop to be Successfully Activated in the Program will be deemed the only valid entry.

Shops that are currently active and participating in the Program ("**Pre-Enrolled Shop**") will automatically be entered into the Sweepstakes with one Entry. If a Pre-Enrolled Shop is chosen as the potential winner, it can choose to decline the Prize.

Who Is the Entrant? The "Entrant" is deemed the Shop. A winner can only be a Shop. Sponsor will notify the Owner, Principal, or General Manager of the chosen Shop of its status as potential winner. If the individual who enrolled the Shop was not authorized to do so, or if the Owner, Principal, or General Manager chooses to decline the Prize, the Prize will be forfeited, and Sponsor will choose a new potential winner from the remaining eligible Entries. The Shop may, in its discretion, determine who within the Shop may receive one or all elements of the Grand Prize, but regardless of such designation, the Shop will be responsible for paying any taxes on the full Grand Prize.

CONDITIONS OF ENTRY / ELIGIBILITY TO WIN. This Sweepstakes is open to legally operated Shops in the forty-eight (48) contiguous United States and the District of Columbia (the "Territory"). By participating in the Sweepstakes, Entrants (i) agree to be bound by these Official Rules, including all

eligibility requirements, and (ii) agree to be bound by the decisions of Sponsor, which are final and binding in all matters. Entries that are incomplete or corrupted are void and will not be eligible. Entries that are not “Successfully activated” (defined above) will not be eligible. Sponsor and its agents reserve the right to verify eligibility qualifications of any chosen winner. Failure to comply with these Official Rules may result in disqualification from the Sweepstakes. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited by law.

Who is not eligible to win? Employees of Sponsor, its subsidiaries, affiliates, advertising and promotion agencies, retailers or distributors, and members of their immediate family (e.g., spouses, parents, domestic partners, children, siblings), are not eligible to win.

SPECIAL PUBLICITY NOTICE. By entering this Sweepstakes, if you are selected as a winner of any prize, you grant to Sponsor and its promotional agents your express permission (except where prohibited by law) to use your name, identity, description of prize won, Shop name, winner’s hometown, and any likeness, if applicable, for promotional purposes, in any media now known or hereafter developed, including on the radio, and including for “live notification” of potential winner status purposes, without further compensation. PRIZE. One (1) Grand Prize will be awarded to one (1) winner using the selection process described below and satisfaction of the eligibility requirements set forth above, consisting of:

- Roundtrip coach airfare for winner & guest from a major commercial airport closest to winner’s location to San Jose del Cabo, Mexico
- 3-night stay (double occupancy) at Marquis Los Cabos, a 5-star All-Inclusive Resort in San Jose del Cabo
- Roundtrip transportation to the Marquis Los Cabos and the Los Cabos International Airport
- A la carte meals, suite services, and premium alcoholic beverages included
- 1-year SXM App subscription.

Approximate Retail Value (“**ARV**”) of the Grand Prize is \$3500.

If a potential winning Shop is unable to receive or accept the Prize, it will forfeit the Prize and another winner will be selected from among eligible Entries received. No prize substitution, cash substitution, assignment, or transfer of prizes is permitted, except by Sponsor who may substitute a prize, in whole or part, of equal or greater value if any portion of the advertised prize becomes unavailable. In no event shall more than the number of stated prizes be awarded. All prizes are intended to be awarded. All federal, state, local and other taxes, costs, and expenses relating to the use, acceptance, and possession of the prize are the sole responsibility of the Shop winner. WINNER SELECTION. The potential winning Shop will be determined by a random drawing following the close of the Entry Period from among all eligible Entries received.

ODDS. Odds of winning depend upon the number of eligible entries received during the Entry Period. This Sweepstakes is intended to be advertised to a maximum of 62,001 service and repair shops and 4,108 Ford Professional Service Network shops not yet enrolled in the Program, and a maximum 8,748 shops already enrolled in the Program. Odds of winning are a maximum of approximately 1:74,857

WINNER AGREEMENTS. Potential Shop winner will be notified by telephone and email using information provided in the Entry. Except where prohibited, acceptance of Prize constitutes Shop winner's consent, and Shop winner will be required to sign a release, to allow Sponsor and its promotional agents to use Shop winner's name and likeness, photo, video footage, and/or biographical data, for advertising and promotional purposes, without additional compensation, in perpetuity, in all media, now known or hereafter developed, in connection with Sponsor, this Sweepstakes, and the Sponsor's web sites. Sponsor may use your personal information, including postal and e-mail addresses, to contact you regarding our goods and services and any other offers and/or promotions that we believe might be of interest to you.

Special Note: We will make no use of the telephone number obtained from your Entry except to contact potential winners and to verify your eligibility to enter.

GENERAL CAUTION / RELEASE. Sponsor reserves the right to permanently disqualify any Entrant it believes has intentionally violated these Official Rules.
