

**SiriusXM Ultimate Outdoor Movie Theater Package Sweepstakes  
for Automotive Shops**

**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A purchase will not increase your chances of winning. Void where prohibited. U.S. law governs. Open only to Shops in the Territory (defined below)**

**SPONSOR:** The Sponsor of this Sweepstakes is Sirius XM Radio Inc., 1221 Avenue of the Americas, 35th Floor, New York, New York 10020.

**ENTRY PERIOD.** The SiriusXM Ultimate Outdoor Movie Theater Package Sweepstakes for Automotive Shops (the “**Sweepstakes**”) begins at 12:01 a.m. Eastern Time (“**ET**”) on May 3, 2021 and ends at 5:59 p.m. ET on July 9, 2021 (the “**Entry Period**”). Any entries received after the Entry Period will not be considered.

**HOW TO ENTER.** An owner or authorized employee of a service and repair shop in the Territory (defined below) (a “**Shop**”) may enter the Sweepstakes on behalf of the Shop by enrolling the Shop in the SiriusXM® Service Lane Program (the “**Program**”) and being “successfully activated” in the Program(s). To enter for your chance to win, go to [www.siriusxmforshops.com/Movie2021](http://www.siriusxmforshops.com/Movie2021). Follow the instructions listed to enroll in the Program. A properly completed and received enrollment in a Program that is “successfully activated” shall be considered an “**Entry.**”

“**Successfully activated**” means a Shop enrolled and was accepted into the Program, *and* the Shop received an activation acknowledgement from Sponsor no later than the end of the Entry Period. Only one (1) entry per Shop; the first enrollment to be submitted and cause the Shop to be Successfully Activated in the Program will be deemed the only valid entry.

Shops that are currently active and participating in the Program will automatically be entered into the Sweepstakes with one Entry. If a Shop is chosen as the potential winner, it can choose to decline the prize.

**Who Is the Entrant?** The “**Entrant**” is deemed the Shop. A winner can only be a Shop. Sponsor will notify the Owner, Principal, or General Manager of the chosen Shop of its status as potential winner. If the individual who enrolled the Shop was not authorized to do so, or if the Owner, Principal or General Manager chooses to decline the Prize, the Prize will be forfeited, and Sponsor will choose a new potential winner from the remaining eligible Entries. The Shop may, in its discretion, determine who within the Shop may receive one or all elements of the Prize, but regardless of such designation, will be responsible for paying any taxes on the full Prize.

**CONDITIONS OF ENTRY / ELIGIBILITY TO WIN.** This Sweepstakes is open to legally operated shops in the forty-eight (48) contiguous United States and the District of Columbia (the “**Territory**”). binding in all matters Entries that are incomplete or corrupted are void and will not be eligible. Entries that are not “successfully activated” (defined above) will not be eligible. Sponsor and its agents reserve the right to verify eligibility qualifications of any chosen winner. Failure to comply with these Official Rules may result in disqualification from the Sweepstakes. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited by law.

**Who is not eligible to win?** Employees of Sponsor, or its subsidiaries, affiliates, advertising and promotion agencies, retailers or distributors, and members of their immediate family (e.g., spouses, parents, domestic partners, children, siblings), are not eligible to win.

The Grand Prize Package shall consist of one (1) 20 Feet Inflatable Outdoor and Indoor Theater Projector Screen valued at \$209.95, one (1) Sonos Indoor Outdoor Speaker Set valued at \$598.00, one (1) Yeti Tundra 65 Hard Cooler valued at \$349.99, one (1) Great Northern Popcorn Black Paducah 8 Ounce Antique Popcorn Machine and Cart valued at \$329.99, one (2) Pack KingCamp Black/Navy Heavy Duty Compact Camping Folding Mesh Chair with Side Table and Handle valued at \$144.99, two (2) SiriusXM Wine Tumblers valued at \$52.00, one (1) SiriusXM Large Water Proof Lawn Blanket valued at \$149.99, and one (1) FREE 1 Year of The Best SiriusXM Streaming Package valued at \$156.00.
