OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A purchase will not increase your chances of winning. Void where prohibited. U.S. law governs. Open only to Shops in the Territory (defined below)

ENTRY PERIOD. The SiriusXM Ultimate Rock Your Shop Sweepstakes for Automotive Shops (the **"Sweepstakes"**) begins at 12:01 a.m. Eastern Time (**"ET"**) on February 16, 2021 and ends at 5:59 p.m. ET on April 16, 2021 (the **"Entry Period"**). An owner or authorized employee of a service and repair shop in the Territory (defined below) (a "*Shop*") may enter the Sweepstakes on behalf of the Shop by enrolling the Shop in the SiriusXM® Service Lane Program (the "*Program*") and being "successfully activated" in the Program(s). A properly completed and received enrollment in a Program that is "successfully activated" shall be considered an "*Entry.*"

"Successfully activated" means a Shop enrolled and was accepted into the Program, and the Shop received an activation acknowledgement from Sponsor no later than the end of the Entry Period.
