Service and Repair Shop Owners who want to enroll in the Service Lane for Program (the "Program") can enter Shops by going to www.siriusxmforshops.com/DAYTONA500, enrolling, and being "successfully activated" in the Program (referred to herein as the "New Shop Owner Enrollment Entry Pool"), from 12:01 am ET on November 25, 2019 to 6:00 pm ET on January 17, 2020 (the "Entry Period"). "Successfully activated" means a Service and Repair Shop (the "Shop") was accepted into a Program and the Shop received an activation acknowledgement from Sirius XM Radio Inc. by January 17, 2020. Shop Owners currently active and participating in the Program (referred to herein as the "**Participating Shops Entry Pool**") will automatically be entered into this sweepstakes with one Entry awarded. If a shop is chosen a winner, it can choose to decline the prize.
